## Program

**Jim Jackson**, Executive Director of Disability Rights New Mexico, and his associate, **Ellen Pinnes**, gave an informative presentation about service animals (for the most part dogs), their treatment, and the responsibilities of businesses to accommodate them. Under Federal and State law, businesses can inquire whether a dog brought into an establishment is a service dog needed due to a disability, but they cannot inquire into the nature of the disability or require that the dog wear some sort of identification as a service animal. They can also ask what particular tasks a dog is trained to perform, but cannot inquire how that task relates to the owner's disability.
