Other Developments

The club received an award of \$2,740 from District 5520 for its 2019-20 District Grant project. The club board subsequently decided that, in light of the smaller than expected amount of the grant, the project had to be cut back. We will use all the available funding for the Kindergarten Book project and drop the scholarship expansion portion of the original project proposal. The original project budget of \$10,200 will be cut back to \$4,000. **Wendy Spurgeon**, with the help of **Kathy Eaton**, agreed to coordinate the Kindergarten Book Project this year. Meanwhile, our scholarship projects will continue as in the past.

District Governor-Elect Sunny Kellerman, announced that, for a variety of reasons, the 2021 District Conference will not be held in Silver City as originally planned. Instead, it will take place in Las Cruces on April 7-11, 2021 and will be combined with the President-Elect Training Seminar (PETS).
